Students who have already re-registered with IGNOU by paying Rs.4500/- and appeared during 2016-2017 academic session but were unsuccessful are required to pay the subject fees only. All such students of 2010-2011 batch should be clearly informed that this would be the last chance to clear the B.Sc. degree examination during 2017-2018 academic session.
